AMENDMENTS TO DEPED MEMORANDUM NO. 257, S. 2010 (Conduct of the 2010 National Qualifying Examination (NQE) for School Heads and Qualifying Process for Reclassification of School Heads Positions (RSHP))

To: Bureau Directors
Directors of Services, Centers and Heads of Units
Regional Directors
Schools Division/City Superintendents
Heads, Public Elementary and Secondary Schools

- 1. The administration of the 2010 National Qualifying Examination (NQE) for School Heads and Qualifying Process for Reclassification of School Heads Positions (RSHP) was announced in DepEd Memorandum No. 257, s. 2010.
- 2. Item No. 3 is hereby amended and shall read as follows:

"Incumbent Principals I, II or III and passers of the 2006 or 2007 qualifying examination for principals conducted by the regional office or by the National Educators Academy of the Philippines (NEAP) and passers of the 2008 or 2009 National Qualifying Examination for Principals (NQEP) conducted by the NEAP are exempted from taking the NQE-RSHP and may apply for reclassification for the desired school head positions if they meet the basic requirements for reclassification and if they are holders of Certificate of Eligibility for School Head issued by NEAP."

- 3. Item No. 6, Sections (b) and (c) of said Memorandum are hereby amended and shall read as follows:
 - "(b) File application forms with the required documents and the examination fee with the Personnel Office of respective division offices on or before July 9, 2010"; and
 - "(c) The division offices will be responsible in processing the application forms to determine the qualifications and eligibility of the aspirants to take the examination and in submitting the official list of applicants to the regional office, **Attention: NEAP Region Competency Assessment Team Leader**, who will submit the official list per division to the NEAP Central through e-mail address: depedneap central@yahoo.com on or before July 16, 2010.
- 4. Moreover, the conduct of the said examination is hereby deferred until further notice. The final date of the examination will be announced in due time through an Official Advisory to be issued by the National Educators Academy of the Philippines (NEAP) Central Office.
- 5. Immediate dissemination of this Memorandum is desired.
