## FIRST NATIONAL ANTI-DRUG MUSICAL SUMMIT

- 1. The Recovery Circle Foundation (RCF), Inc. in cooperation with the Department of the Interior and Local Government (DILG), Philippine Drug Enforcement Agency (PDEA), Dangerous Drugs Board (DDB) and the San Juan City Government will hold the *First National Anti-Drug Musical Summit* on June 26, 2010 at the San Juan Arena, Pinaglabanan St., San Juan City.

- 3. The summit is open to the public, especially students, educators, teachers, school officials, civil society leaders, national and local government officials, barangay officials, religious groups, and other members of the civil society.
