INCLUSION OF AMATEUR BOXING IN THE DEC
INTEGRATED PHYSICAL FITNESS AND
SPORTS DEVELOPMENT PROGRAM

To: Bureau Directors
Regional Directors
Coordinator, State Colleges and Universities
Schools Superintendents

1. Amateur boxing will be included as a regular event in all athletic meets under the Integrated Sports Development Program of the Department of Education and Culture starting this school year, 1976-1977.

2. There will be two (2) groups in the amateur boxing competitions. Group I will be exclusively for youths who are not below 12 years and not more than 14 years and 6 months old. Group II will be exclusively for youths who are not less than 14 years and 7 months; nor more than 17 years and 6 months old, as of March 30 of every Palarong Pambansa year. These groupings on age levels should be strictly observed. Youths whose ages fall in Group I cannot play in Group II and vice versa.

3. Competitions will further be classified as follows:

Group I	Group II
12-14 years 6 mos. old	14 yrs. 7 mos. to 17 yrs. 6 mos. old

d. BANTAMWEIGHT - weight over 51 kgs. but not to exceed 54 kgs. or 119 lbs.

d. BANTAMWEIGHT - weight over 51 kgs. but not to exceed 54 kgs. or 119 lbs.

4. The rules and regulations of the Association Internationale De Boxe Amateur (A.I.B.A.) and adopted by the Amateur Boxing Association of the Philippines (A.B.A.P.) with some amendments by the DEC to suit local conditions shall govern all amateur boxing competitions in all DEC athletic meets.
