DESIGNATING AN ACTION COMMITTEE FOR THE IMPLEMENTATION OF
THE GREEN REVOLUTION, TOOL MAKING, NUTRITION AND HEALTH,
YOUTH CIVIC ACTION, ENVIRONMENTAL EDUCATION, ALAY
TANIM, AND IN-SERVICE EDUCATION OF TEACHERS IN
ELEMENTARY AGRICULTURE (MATEA) PROGRAMS

1. In order to achieve a more effective implementation of the Green Revolution, Tool Making, Nutrition and Health, Youth Civic Action, Alay Tanim, Environmental Education, and the In-Service Education of Teachers in Elementary Agriculture (MATEA) Programs of the Department of Education and Culture, the following Action Team is hereby designated:

2. The Action Committee shall exercise the following functions:

- a. To coordinate with government agencies concerned in the implementation of the above-mentioned programs;
- b. To encourage innovative and action research activities in food production, tool making, nutrition, Youth Civic Action, and human resource development in agriculture;
- c. To supervise the management and control of the programs including operating funds and recommend policies to promote efficiency;



- d. To coordinate with cooperating institutions on the MATEBA program and other agencies working toward the same or similar objectives;
 - e. To keep records, gather data, set guidelines and expand the programs to all regions in the country whenever feasible.
3. For effective and coordinated action on the implementation of this Department Order, the Action Committee shall hold its office at the Department of Education and Culture, Manila, under the direct supervision of the Chairman. The Team shall tap the services of specialists or experts in appropriate fields to enrich the activities of the programs.
4. The Action Committee shall likewise designate support personnel as may be necessary for the implementation of this Department Order.
5. MATEBA Centers and Cooperating Institutions shall, whenever possible, assist in financing the implementation of this Department Order.
6. This Department Order takes effect immediately.
