BUDGET CIRCULAR NO. 271-A

SUBJECT : Clarifying and Illustrating the Provision of
Item 3.1 of Budget Circular No. 271

1.0 Basis for Computing Percentage Salary Adjustment

The basis for computing the percentage adjustment authorized in B.C. 271 is the actual salary of the incumbent as of March 31, 1977 or the maximum of the range allocation of his position as of that date, whichever is lower; but the adjusted salary shall not be more than P600 a month or P20 a day.

Illustrative Examples:

- 1.1 Employee is a Senior Clerk, R-42 (P4632-5640) and his actual salary as of March 31, 1977 is P5376. The 10% salary adjustment shall be based on P5376, the actual salary, which is within the range allocation of the position and is lower than the maximum. Thus, 10% of P5376 equals P537.60 and the adjusted salary P5913.60 p.a.
- 1.2 If the same employee in 1.1 has an actual salary of P5928 as of March 31, 1977, the 10% salary adjustment will be based on P5640, the maximum of the range allocation of the position, which is lower than the actual salary. Thus, 10% of P5640 equals P564, and the adjusted salary P6204 p.a.

2.0 This Circular shall take effect May 1, 1977.
