SUBMISSION OF SCHEDULE OF FEES A PRE-REQUISITE FOR THE GRANT OF PERMIT FOR NEW COURSES

1. Section 5 of Department Order No. 65, s. 1976, Revised Implementing Rules and Regulations for Presidential Decree No. 451, provides:

Beginning the school year 1977-78 "the approval of the proposed rates or schedule of tuition and/or other school flees of each new school or course as provided in Section 2 hereof, shall be a condition-precedent, among the other requirements, for the grant of cauthority to operate the new school or course pursuant to the mandate of Act No. 2706, as amended."

2. I Accordingly, no application for permit in private schools, whether for a new school/course or for an additional grade or curriculum year in an existing course, shall be considered or recommended favorably unless the application submitted includes the proper schedule of fees on Form II, in triplicate, for each new course or additional grade/curriculum year. Without such schedule of fees, the application shall be considered automatically disapproved from date of filing. The applicant-school shall be informed accordingly thereon.

 - 19. SCHEDULE OF FEES. Has the school submitted a schedule of fees on Form II, in triplicate, for each new course or additional grade/curriculum year herein applied for Is it attached hereto?
 - 4. Likewise, the following item shall be added on the application form for Permit (Form 1):
 - 13. Schedule of fees. Inclosed is the proposed schedule of fees on Form II, in triplicate, for each new course or additional grade/curriculum year herein applied for. It is understood that my/our failure to inclose this important requirement shall cause automatic disapproval of this application.
 - 5. It is desired that immediate dissemination of the contents of this Memorandum be made for strict compliance by all concerned.
