ACCREDITATION OF THE DEC LEVEL IV
TEACHER TFAINING PROGRAM

- 1. In accordance with LOI No. 522 and Department Memorandum No. 115, s. 1977 training institutes, otherwise known as Level IV training, were conducted for teachers for eighteen (18) Saturdays or a minimum of 72 hours. It may be stated that the program consisted of two subject offerings, one on "Foundation of Contemporary Philippine Education" which stressed the major thrusts of the government toward the huilding of the new social order and the second on "Development Strategies in Administration and Instruction" dealing mainly on modern management concepts and practices and dynamics of effective teaching.
- 2. Department Memorandum No. 115, s. 1977 indicated that teachers who completed the 72-hour institute will be entitled to four units of apademic credit. In this connection, the following scheme of accreditation is hereby provided:

Upon presentation of his/her certificate of completion of the Level IV training course, the teacher who is a backalaureate degree holder will be granted two (2) units each for the two subjects or a total of four (4) units in the degree programs of Master of Arts in Education, Master of Arts in Teaching, Master of Arts in Teaching Elementary Agriculture (MATEA), and other master's courses in Teacher Education. The teacher who holds a master's degree in any of the above-mentioned graduate courses will be allowed four (4) units in the doctoral program in Education. The non-degree-holder teacher will be given four (4) units in the B.S.E., B.S.E.Ed., or other appropriate undergraduate teacher education course.

Government and private colleges and universities with duly authorized education courses on the undergraduate and/or graduate (masteral-doctoral) levels are hereby authorized to grant the corresponding credits. A reasonable registration fee not exceeding ten pesos (F10) may be charged by the accrediting college or university.
- 4. The accrediting institution should submit to the regional office the names of the teachers given credit under this accreditation scheme.
- 5. The cooperation of all concerned for the proper, immediate implementation of this Department Order is enjoined.
