EXEMPTION FROM CITIZEN ARMY TRAINING (CAT)  
AND BASIC PHYSICAL EDUCATION REQUIREMENTS

To: Bureau Directors  
Regional Directors  
Coordinator, State Colleges and Universities  
Schools Superintendents

1. For the information and guidance of the field, this Office forthwith sets the rules on the exemption of Scouts from Citizen Army Training (CAT) and from the Basic Physical Education requirements:
  - a. Scouts who are 4th year high school students and who have attained the Service Badge or formerly First Class rank or who have participated in recognized Scouting events overseas, may be exempted from Citizen Army Training (CAT) upon recommendation of the Boy Scouts of the Philippines National Headquarters and approval of the Department of Education and Culture.
  - b. Scouts who are post-secondary education (college) students who have attained the Service Badge or any award above this or who have participated in recognized Scouting events overseas, may also be considered for exemption from the Basic Physical Education requirements, likewise upon the recommendation of the Boy Scouts of the Philippines National Headquarters and approval of the Department of Education and Culture.
2. The attached forms should be used in applying for exemption. Copies may be produced by BSP Local Council or BSP Regional Service Centers and furnished to interested parties.
3. Immediate dissemination of the contents of this Department Order is desired.
