GUIDELINES ON THE PLACEMENT IN SCHOOL OF THOSE WHO TOOK THE 1977-1978 PHILIPPINE EDUCATIONAL PLACEMENT TEST

To: Bureau Directors
Regional Directors
Chiefs of Services and Heads of Units
Coordinator, State Colleges and Universities
Schools Superintendents
Heads of Private Schools, Colleges and Universities

- 1. The results of the Philippine Educational Placement Test (PEPT) first administered during the second semester of school year 1977-1978 have been released in the form of certificates dated July 25, 1978. They bear the signature of the Minister of Education and Culture, the seal of the NETC at the upper left hand corner, the dry seal of the same office at the lower left hand corner and the initials of two NETC personnel just below the Minister's signature.
- 2. The information contained in the certificates include the examination number, grade/year level completed when the examines dropped out, the standard scores and their corresponding grade/year equivalents in Communication Arts (English and Filipino) and in Mathematics both printed in words. The examinee's grade/year level, where he/she meets the basic academic requirements is indicated in the last paragraph.
- 3. For the information and guidance of the field on the placement of the examinees who took the PEPT the following guidelines are being issued:
 - a. Those who are presently enrolled in the grade/year level where they dropped out are to be reclassified in the grade/year level stipulated in the certificate upon presentation of such;

- b. Those who have not been enrolled due to the delay in the release of the PEPT results may now be admitted in the grade/year level indicated in the Certificate. Last day of acceptance for enrolment is August 30, 1978;
- c. Those who are at present enrelled in the elementary but whose PEPT results qualify them for high school may be admitted in any secondary school within the district where they are now studying or in any other secondary school provided that the enrolment is between now and August 30, 1978,
- d. Those who met the basic academic requirements for fourth year may now be admitted to the college level subject to the admission requirements of the school;
- e. The following is to be indicated on Form 137

 "Placed in/Reclassified to on (Grade/Year level)

 the basis of the PEPT results dated July 25, 1978

 with Examination Number ." The Certificate should be attached to the Form 137;
- f. Great care should be exercised in determining the authenticity of the Certificate by verifying if the information specified in paragraph one are contained therein; and
- g. The Certificate issued by this office based on the results of the PEPT is to be considered as equivalent to Form 138 issued by the school heads.
- 4. Immediate dissemination of this MEC Order and strict compliance thereto is enjoined.
