CLARIFYING PARAGRAPH 27.i OF DEPARTMENT ORDER NO. 60, s. 1975  
ON SCHOOL SITE AND BUILDING

To: Bureau Directors  
Regional Directors  
Schools Superintendents  
Heads of Private Schools, Colleges and Universities

1. Paragraph 27.i of the guidelines inclosed to Department Order No. 60, s. 1975 exempts nursery, kindergarten, and special vocational schools from the requirement on ownership of site and building. The said policy, insofar as nursery and kindergarten schools are concerned, was based on B.Pr.S. Circular No. 8, s. 1967, "Exemption of Kindergarten and Elementary Schools from the Requirement on Ownership of Site and Building," copy inclosed. However, elementary schools were not mentioned in the aforementioned Paragraph 27.i of Department Order No. 60, s. 1975.

2. Accordingly, said Paragraph 27.i is hereby amended to read as follows:

Policy exempting nursery, kindergarten, elementary, and special vocational schools from requirement of ownership of site and building, provided same are leased for at least 10 years and provided further that they limit their operation to nursery, kindergarten, elementary and special vocational courses only.

3. This Order shall take effect immediately and shall be observed by all concerned.

EXEMPTION OF KINDERGARTEN AND ELEMENTARY SCHOOLS  
FROM THE REQUIREMENT ON OWNERSHIP OF SITE AND BUILDING

To Heads of Kindergarten  
and Elementary Schools:

1. Effective the 1967-68 school year, all kindergarten and elementary schools are exempted from the requirement on ownership of site and building, provided that the same are leased for at least 10 years.
2. This exemption is valid only for as long as the schools concerned limit their offerings to kindergarten and/or elementary courses.
3. This Circular amends Par. 39 of the Manual of Information for Private Schools, Sixth Edition, insofar as kindergarten and elementary schools are concerned.
