GUIDELINES ON THE PLACEMENT IN SCHOOL OF THOSE WHO TOOK  
THE 1978-1979 PHILIPPINE EDUCATIONAL PLACEMENT TEST

To: Bureau Directors  
Regional Directors  
Chiefs of Services and Heads of Units  
Presidents, State Colleges and Universities  
Schools Superintendents  
Heads of Private Schools, Colleges and Universities

1. The results of the Philippine Educational Placement Test (PEPT) administered during the second semester of school year 1978-79 have been released in the form of certificates dated May 1979. Each certificate bears the signature of the Minister of Education and Culture, the seal of the NETC at the upper left hand corner, the dry seal of the same office at the lower left hand corner, the initials of Mrs. Lucila F. Tibigar (Lft), Accreditation and Equivalency Program Officer and the initial of another member of the NETC immediately below the Minister's signature.
2. The information contained in the certification includes the examination number, grade/year level completed when the examinee dropped out, the standard scores and their corresponding grade/year equivalents in Communication Arts (English and Pilipino) and in Mathematics, both printed in words. The examinee's grade/year level where he/she meets the basic academic requirements as evidenced by the test results, is indicated in the last paragraph.
3. For the information and guidance of the field on the placement of the examinees who took the PEPT, the following guidelines are being issued:
  - a. Those who are presently enrolled in the grade/year level where they dropped out are to be reclassified in the grade/year level stipulated upon presentation of the certificate;
  - b. Those who have not been enrolled for failure to receive the PEPT results before the enrolment period may be admitted in the grade/year level indicated in the Certificate. Last day for their enrolment is July 31, 1979;







- c. Those who are currently enrolled in the elementary level but whose PEPT results qualify them for high school may be admitted in any secondary school on or before July 31, 1979.
4. The following is to be indicated in Form 137: "Placed/Reclassified in \_\_\_\_\_ on the basis of the PEPT results (Grade/Year level) dated February-March, 1979 with Examination Number \_\_\_\_\_."
5. The Certificate should be attached to the Form 137.
6. Care should be exercised in determining the authenticity of the Certificate by verifying the information specified in paragraph one.
7. The Certificate issued by this Office based on the results of the PEPT takes the place of Form 138 issued by the school heads.
8. Immediate dissemination of and strict compliance with this Order is enjoined.
