AMENDING CERTAIN PROVISIONS OF MEC ORDER NO. 32, s. 1978

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities

1. Effective this school year, 1979-1980, Paragraph 5 and item (m) of Paragraph 7, of MEC Order No. 32, s. 1978 entitled "Changes in the Guidelines for the Conduct of Athletic Meets," are hereby amended to read as follows:

"The inclusion of field events in provincial and lower level meets may be on a selection basis; that is, only such events as resources and developmental possibilities warrant may be included. However, field events shall be a regular part of athletics in the regional meet and the Palarong Pambansa."

"7 (m) - Protests concerning eligibility shall be in writing, endorsed by the head of the delegation and supported with authentic documents. No protest against any member of a team shall be accepted after the said team has started playing its second game, except in case of impersonation or falsification of documents. The General Referee shall, upon recommendation of the Chairman of the Screening Committee, immediately debar any athlete found ineligible from playing in the remaining games of the team in which he is originally listed. No substitution of any debarred athlete shall be allowed.

2. Immediate dissemination of these guidelines is desired.
