- 1. For the information and guidance of all concerned, Memorandum Circular No. 13, s. 1979 of the Civil Service Commission on the subject "Additional Guidelines in the Submission of Appointments to the Civil Service Commission" is printed on the reverse side.
- 2. Conformably thereto, a statement that the appointee has been properly screened and found qualified by the Selection or Promotion Board, duly certified by the Chairman of the Selection or Promotion Board, as the case may be, should be placed on the face of the appointment. Likewise, a copy of the list of qualified candidates from which the appointee was selected, authenticated by the Chairman of the Selection or Promotion Board, as the case may be, should be submitted together with the appointment.

SUBJECT ATMAdditional Guidelines in the Submission of Appointments to the Civil Service Commission

Letter of Instructions No. 799 provides that no appointment shall be acted upon by the Civil Service Commission unless the ampointee has been properly screened by the Selection/Promotion Board. It has been observed that in the absence of clear cut instructions on how to comply with this provision, agencies have resorted to different approaches. Therefore, to insure uniformity and to insure that the philosophy behind the requirement is not, defeated, the following additional guidelines are hereby issued:

- 1. The Chairman of the Board shall certify to the fact that the appointee has been properly screened and found qualified by the Selection Such certification Board. Such certification shall be placed on the face of the appointment
- 2. A copy of the list of qualified candidates recommended by the Board from which the appointed was selected authenticated by the Chairman of the Board shall be submitted together with the second a ing set as the second of the s appointment.
