PROCESSING OF APPLICATIONS FOR PASSPORT OF STUDENTS, SCHOLARS, TRAINEES AND PARTICIPANTS IN ANY PROGRAM UNDER THE MEC

In order to expedite the processing of applications for passports and travel documents of Filipinos going abroad as students, researchers, scientists, educators, economists, etc. to study, attend conferences, lectures, seminars and/or participate in training programs, a Memorandum of Agreement was entered into by the Ministry of Education and Culture (MEC), Ministry of Foreign Affairs (MFA), the National Economic and Development Authority (NEDA), the Ministry of National Defense (MOND) and other agencies concerned.

- 2. The said agreement has defined the scope and responsibility of each government agency in the implementation thereof.
- 3. The responsibilities of the Ministry of Education and Culture are indicated below:

MEC (Thru the Foreign Students and Foreign Schools Office)

- a. Receives and processes applications for students and youth exchange programs, and for educators on educational tours, travel grants, scholarship or training.
- b. Coordinates with MFA and other agencies concerned on matters relevant to their requirements or area of interest.

- c. Maintains a complete and updated information on participants referred to in paragraph 3-a.
- d. Conducts pre-departure orientation for participants along Philippine culture, geography, history, government and other pertinent data.

In order to maintain a centralized control system, the following procedures will be followed:

- a. All scholerships, so long as the ficiary is a private individual, be coursed through the Foreign Students and Foreign Schools Office, MEC, the final selection of candidates is done.
- b. Pre-departure orientation (PDO) will be conducted at the MEC Training Center by the Cultural Affairs Office of the MEC:
- c. Pre-departure orientation for those who are going to the Socialist countries will be conducted by an appropriate agency to be recommended by the FSFSO.
- 5. Any provision of existing MEC regulations inconsistent with this MEC Order is hereby repealed and/or modified accordingly and made part of this Order.
- 6. This Order takes effect immediately. Strict compliance by all concerned is desired.
