AMENDMENT TO MEC ORDER NO. 40, S. 1980

1. Paragraphs 3, 4, and 5, of MEC Order No. 40, s. 1980, entitled "Project Executive Team (PET) for the Program for Decentralized Educational Development" are hereby amended to read as follows:

"3. It is for these reasons that the Project
Management Committee (PMC), created through
MEC Order No. 73, s. 1979, has been reconstituted and is now known as the Project Executive
Team (PET). This Team is composed of members
of the staff of the Minister of Education and
Culture whose functions are closely tied up
with the sectoral program and the Chairman of
the Textbook Board. The members of the Project
Executive Team are:

Director, Bureau of Elemen
tary Education - Vice Chairperson
Chief, Planning Service - Member

EDPITAF - "
Chairman, Textbook Board - "

- "4. The Team shall have the following functions:
 - a. Serve as advisory body to the Minister on policy matters;
 - b. Serve as executive arm of the Minister,

- c. Supervise and evaluate the planning, implementation of management of programs, projects and subprojects, and propose measures for the improvement of performance;
- d. Supervise disbursement, accounting and liquidation of funds and other matters; and
 - e. Review and approve proposals for research on a national scope.
- "5. The Team shall maintain a Project Technical Staff
 (PTS) headed by a Project Director. This position
 shall be occupied by the Assistant Director of the
 Bureau of Elementary Education (BEE). It shall
 have a core of full-time staff and shall be supported by part-time consultants and experts. The
 role of the PTS is now modified from solely performing housekeeping functions to serving as a
 technical supervisory arm of the PET as well."
- 2. It is desired that this Memorandum be disseminated for the information and guidance of all concerned.
