REGIONALIZATION OF THE ADMINISTRATION OF THE KABATAANG
BARANGAY SCHOLARSHIP PROGRAM

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities
Vocational School Superintendents/Administrators

1. In line with the government's efforts toward direct and facilitative services to the public and the institution of measures to avoid red tape, the administration of the Kabataang Barangay Scholarship Program (KBSP), as announced in an Unnumbered Memorandum dated March 23, 1981, shall be handled by the MEC regional offices, particularly in Regions II, III, VIII, X and XI, where the Program is currently operational, in coordination with other government regional offices concerned, effective school year 1981-1982.
2. The regional offices shall observe the policies, rules and regulations governing the KBSP embodied in the General Information Manual and in other implementing rules that will be issued from time to time.
3. The regional offices concerned shall attend to, among other things, the initial screening of applicants, channeling of the awardees to the specific courses and schools prescribed by the Program, processing and evaluation of the academic performance of the KB scholars, issuance of notices of continuance or discontinuance of the scholarship, facilitating the preparation of the master list of scholars entitled to payment of their stipends and school accounts through the services of the PNB branches, guidance and counselling services, job placement/assistance to graduates and other pertinent matters.
4. The National Scholarship Center, tasked as the administering agency of this Program pursuant to a Memorandum of Agreement forged with the KB Foundation Inc. to this effect, shall now perform monitoring, overseeing, program evaluating and policy recommending functions, in addition to its involvement in the national screening of applicants.

5. The YE Foundation, Inc. underwrites the Program expenditures and the scholarship funds are deposited with the PNB Metropolitan Theatre Extension Office. The Bank, upon notice from the regional office through the National Scholarship Center, remits the amount to the PNB branches concerned through credit advice for the payment of the scholars' stipends and school accounts.

6. Immediate dissemination and compliance with this Order by those concerned are hereby enjoined.
