In line with the approval of the President dated April 26, 1982 of our memorandum on the additional salary increase of teachers effective January 1, 1982, I am pleased to inform you that you may now implement the P96.00/month across-the-board additional salary increase of teachers and related teaching positions in the MEC.

The P96.00/month across-the-board increase for teachers and related teaching positions, and also the positions falling under the Educational Supervision and Planning Group will raise the monthly take home pay of the lowest level teaching positions from P904/month to P1,000/month inclusive of allowances, broken down as follows:

Likewise, the same P96.00/month across-the-board salary increase will apply to the succeeding **higher** levels of teaching positions who were also beneficiaries under NCC No. 17.

Effective January 1, 1982, all original appointments to classes of positions which are beneficiaries of NCC No. 17, including those classes of positions under the Educational Supervision and Planning Group, shall not be lower than the minimum of the upgraded salary range under NCC No. 17, plus the approved P96.00/month.

The Personnel Officer/Administrative Officer of the Ministry of Education and Culture, Regional Office/Agency, shall prepare for purposes of this salary increases/adjustments, the Plantilla of Personnel and Salary Adjustment Form herein attached, as ANNEX "A".

The Regional Director, MEC, shall notify the employee/official in writing of his adjusted salary through a notice of Salary Adjustment Form as prescribed, herein attached as ANNEX "B". A copy of the Notice of Salary Adjustments shall be furnished the GSIS.

The Regional Director, MEC, shall be held personally liable for any payment of salary increase/adjustment not in accordance with the herein rules, and for the non-submission of the required reports without prejudice, however, to refund any excess payment by the employee concerned.

The salary adjustment herein authorized may be paid even before the receipt by the Agency of the Advice of Allot-ment from the Office of Budget and Management. The Cash Disbursement Ceiling for the purpose shall be issued by the Office of Budget and Management even before the release of said Advice of Allotment, provided that the request shall be supported by a duly accomplished statement showing that the amount required cannot be covered from the Cash Disbursement Ceiling already allowed to the Agency on the basis of its regular allotment.

The Accounting Officer of the Regional Office, shall accomplish and submit to the Office of Budget and Management not later than fifteen (15) days from the end of the preceding month a statement of actual payments for salary increases/adjustments made during the preceding month on the basis of which the Advice of Allotment for the purpose shall be issued. Prescribed form is attached herewith as ANNEX "C".

The head of the Regional Office, shall submit on or before July 15, 1982, the Plantilla of Personnel and Salary Adjustment Form.

The salary increases/adjustments herein authorized are subject to the mandatory requirements of GSIS life and retirement insurance premiums and the Home Development Mutual Fund of 1980.

The amounts needed to implement this salary increases/adjustments shall be taken from the salary lapses and other Personal Services Savings of the Ministry of Education.

Any remaining deficiency shall be covered by the Salary Adjustment Fund in the CY 1982 General Appropriations Act and from budgetary reserves, with the approval of the Minister of the Budget.

The Salary Adjustment Fund shall be used only if the salary lapses and other Personal Services Savings of the MEC is already exhausted.

No action shall be subsequently taken in the use of personal services savings for Agencies which are authorized to draw against the Salary Adjustment Fund.

Notwithstanding the provision of any other rule, no employee shall be given a salary increase/adjustment which will raise his salary higher than the salary of his immediate supervisor.

Cases not covered by the rules of this increase/adjustment shall be submitted to the Minister of the Budget for appropriate action and/or recommendation.
