FULL IMPLEMENTATION OF THE SALARY INCREASES/ADJUSTMENTS  
FOR MEDICAL SERVICES SUPERVISOR I IN REGIONAL OFFICES  
AND OF SCHOOLS MEDICAL OFFICERS IN SCHOOL DIVISIONS

To: Regional Directors  
Cultural Agency Directors  
Schools Superintendents  
Presidents, State Colleges and Universities  
Vocational School Superintendents/Administrators

1. Inclosed is a copy of a letter of the Minister of the Budget dated October 4, 1982 on queries raised in connection with the implementation of salary increases/adjustments of the positions of Medical Services Supervisor I in the regional offices and of schools medical officers in the school divisions of the Ministry, which is self-explanatory.

2. Conformably thereto, it is desired that the salaries of those concerned be adjusted effective January 1, 1982 following the guidelines in NCC No. 22 dated June 17, 1982.

S i r :

This has reference to the requests (list attached) for the full implementation of the salary increases/adjustments of the positions of Medical Services Supervisor I in the Regional Offices and of Schools Division Medical Officers in the school divisions of the MECS.

It is represented that the position of Medical Services Supervisor I, (R-79 as upgraded) in the Regional Offices of the MECS, is under the administrative supervision of the Administrative Officer III, R-70. However, it is shown in the position chart submitted, that positions of Medical Services Supervisor I, in the MECS Regional Offices, and the Schools Division Medical Officers in the school divisions are under the technical supervision of the Medical Services Supervisor II of the School Health and Nutrition Center of the MECS, and the Medical Services Supervisor I, of the Regional Offices, respectively.

National Compensation Circular No. 22 s. 1982 was issued in compliance with Executive Order No. 80, dated May 21, 1982, upgrading the Physician classes of positions in the National Government effective January 1, 1982, to fully implement the 1979 Salary Survey and as an advanced implementation of the 1981 Salary Survey.

Item No. 30.4, Chapter 3 of the Ministry of the Budget Operations Manual on Compensation and Classification Operations provides that:

"Notwithstanding the provisions of any other rule, no official or employee shall be appointed at a higher salary rate than that of his immediate supervisor. The salary rule shall not apply when at the time of the appointment of the immediate supervisor, the employee of the subordinate position is already enjoying the higher salary rate

or when the situation is caused by the operation of compensation scheme which are governed by different systems where a salary adjustment under one does not simultaneously take effect with the other." (Underscoring supplied)

Moreover, Medical Services Supervisor I positions are not under the technical and functional supervision of the Administrative Officer III but is only under his immediate supervision.

In view of the foregoing, the salary increases/ adjustments for subject positions under NCC No. 22 may be fully implemented effective January 1, 1982, subject to the availability of funds and the usual accounting and auditing rules and regulations.
