- b. Oversee and coordinate with other offices and agencies for an effective and efficient implementation of KKK and related programs and projects.
- c. Assist in the conduct of training programs in the regional and division levels.
- d. Monitor and evaluate MECS-KKK and related projects and activities.

6. This Order supersedes MECS Order No. 12, s. 1982 and all those detailed with the MECS-KKK National Secretariat are advised to report back to their respective offices of origin, except those who are to be reassigned under the new set-up.

7. This Order shall take effect immediately.
