ADMINISTRATIVE ACTIONS RE ABOLISHED MECS YOAR CENTER

- 1. Apropos to the abolition of the National Yeap Center of the Ministry as earlier ordered by this Office, the following YCAP-related matters or aspects shall be looked into by the corresponding committees organized herein, with the view to effect or decide on the necessary administrative actions to be effected thereon before the start of SY 83-84.
 - a. Re: Personnel. An inventory of personnel assigned to the defunct MECS-YCAP Center be conducted, the purpose of which is either to have them (1) reassigned to other agencies or units of the Ministry, or (2) reverted to their mother agencies or units, effective as of June 16, 1983.

b. Re: Funds. An accounting and auditing be undertaken on funds allocated for the defunct Center, including income and/or grant-funds, if any, for the period from January 1979 to May 8, 1983, for the three-fold purpose of determining: (1) the total annual allocations of the said Center, including its incomes, and/or grant-funds, if any, for the four-year period: (2) the period, annually, including the validity or legality as well as reasonableness of such disbursements; and (3) the balance of said funds, including the income, and/or grant-funds, if any, or the remaining financial obligations of the said Center; if any, as of date.

In determining the income and/or grant funds, of the defunct Center, due care should be observed in distinguishing it from the privately organized YCAP Foundation, Inc.

which evidently had jointly sponsored income-generating projects with the Ministry through the said Center.

c. Re: Property and Records. - An inventory of all properties and records of the defunct Center as of data, be conducted, for the two-fold purpose of determining (1) the accountability or non-accountability and electrones of the personnel concerned therein; and (2) the cossible reassignment of such properties and/or records either to the Office of the Minister or to any of the agencies of the Ministry. Like in the matter of finance, or funds, for purposes of determining Ministry property and records, due care should be taken to distinguish between public and private property or records in relation to the defunct Center and the YCAP Foundation, Inc. as mentioned in paragraph b hereof.

d. Re: Official YCAP Linkages. - An inventory of all existing official Ministry-linkages with other government agencies or private entities be conducted, for the alternative purposes of either continuing or stopping such arrangements taken in the context of the recently enacted National Service Law. The original copy of the official documents on each of the agreements, if possible, should be obtained for records purposes.

- e. Re: YCAP as a Requirement for Graduation. In view of the promulgation of the National Service Law, it is imperative to re-examine, re-orient and re-direct YCAP as a requirement for graduation of students along the principles and/or mandates of the said law. As per MEC Order No. 30, s. 1982, YCAP has been suspended as a curricular requirement for graduation at all levels of the educational system, beginning with the 1st Semester, 1983-84. A study should accordingly be conducted, and a set of proposals be submitted, with the objective to have YCAP abolished, and in its stead a new curricular requirement for graduation of students in implementation of the National Service Law be formulated, by way of:
 - (1) an integrated <u>curricular provision</u> at the appropriate levels; and

(2) specific/relevant projects, or co-curricular provision as institutional internal responsibility at the higher education level of the educational system.

- 2. The various committees organized under this Order are hereby authorized to call on, or for, any personnel or former personnel and/or records, of the (defunct) MECS National YCAP Center, or any personnel concerned of the Ministry, for interview, consultation, or examination, as the case may be, in aid of their respective assigned tasks as embodied in this Order.
- 3. This Office hereby manifest its desire to clear up and/or finally terminate the existing YCAP and all YCAP-related, problems, by May 1983 at the latest, and to implement the National Service Law visa-vis the educational system beginning the school year 1983-84. The committee reports and recommendations shall accordingly be submitted directly to the Minister, at the latest, on June 15, 1983.
- 4. Priority attention and action on this matter on the part of all concerned is hereby enjoined.
