 - a. Effect the immediate administration of the Ministry over the MYSD equipment, personnel, accountabilities and other administrative matters;
 - b. Review and evaluate existing policies and to prepare a program of activities for the Palarong Pambansa;
 - c. Identify and develop projects, activities and an incentive system supportive of the general programs of physical fitness and the development of amateur sports;
 - d. Identify criteria for the development of physical education curricula in the elementary, secondary and tertiary levels;
 - e. Develop and recommend a plan of action which will reactivate the National Youth and Sports Development Foundation of the Philippines; and
 - f. Develop and recommer 1 a plan of action which will activate LOI No. 1323.
 - The Organizational Structure of the Task Force is inclosed.

4. A cash advance of P500,000 is hereby authorized to finance the operational requirements of the Task Force. Said amount will be charged against the Ministry's KBI 2.4.1 or any available funds of the Ministry. Furthermore, said amount will be given in the form of cash advance to the Special Disbursing Officer of the Task Force.

- 5. Operations Center of the Task Force will be located at the KB Sports Center, Roces Avenue, Quezon City.
- 6. The Task Force is expected to complete its assigned tasks by October 15, 1983.
