MECS ORDER No. 47, s. 1983:

REVISED GUIDELINES FOR THE CONDUCT OF SPORTS MEETS

To: Bureau Directors
Rectanal Directors
Chiefs of Services and Heads of Units
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities

- 1. Pursuant to the recommendations discussed during the Executive Meeting held at the Provincial Capitol, Lacag City, and for a more efficient and effective management of Palarong Pambansa 184, the following guidelines are hereby issued:
 - a. The organizational structure which shall be adopted in all levels of sports meets shall conform to the inclosed Organizational/Functional Chart of the Palarong Parbansa.
 - b. Composition of various committees shall be determined by:
 - (1) The host regional director for the Palarong Pembansa;
 - (2) The host schools superintendent for the regional and provincial meets; and
 - (3) The host principal/district supervisors for the unit/district meets.
 - The composition of the Secretariat and the Games Committee of the Palarong Pambansa shall be determined in consultation with the Bureau of Sports Development.
- 2. All sports events in each division included in the last Palarong Pambansa shall also be adopted in 1984.
- Existing rules on eligibility and participation are amended with respect to the following:

a. <u>Cut-cf-School Youth</u>

- May participate in the integrated division only.
- 21 years and below as of March 30, 1984.
- Enrolled in MECS non-formal education program.
- Not degree holder.
- Not a member of the Armed Forces of the Philippines, INP or Quasi Military Organization.

b. Elementary School

- No change in existing rules and regulations.
- Participation is only up to the regional level
- Exceptional athlotes may participate in the secondary level or in the integrated division provided they meet existing requirements.

c. Technical/Vocational Student

- Same requirements for OSY.
- 4. General Championships:
 - a. General championships shall be determined through medal counts - one gold medal per team championship shall be the basis; and
 - b. Subsequent placing shall be determined by silver and bronze medal counts.
- 5. The provisions of NHCS Order No. 32, s. 1978, with regard to funding shall be adopted.
- 6. Previous rules and regulations issued by this Office which are inconsistent with this Order are hereby rescinded.
