NATIONAL COMPENSATION CIRCULAR 50  
January 20, 1988

TO : Heads of Departments, Bureaus, Offices and Agencies of the National Government, State Colleges and Universities and all Others Concerned

SUBJECT : Grant of Increase to Public or Government Sector Employees Who are Paid on a Daily Wage Basis

---

1. PURPOSE

This Circular is issued to implement Sections I and II of R.A. No. 6640 providing for an increase in the daily wage of government employees who are paid on daily wage basis.

2. COVERAGE

All workers and employees in the government who are paid on a daily wage basis are covered by this Circular.

3. RULES AND REGULATIONS

1. The daily wage of workers and employees in the government shall be increased by P10.
2. The minimum daily rate for all government workers paid on the daily wage basis as adjusted under this Circular shall be P32.65.
3. Daily paid part-time workers shall receive a proportionate increase corresponding to the P10 increase for an eight (8) hour work day.

4. SOURCE OF FUND AND PAYMENT

The wage increase authorized herein as it pertains to CY 1987 service shall be funded from the COAF, the Contingent Fund, and other savings under E.O. No. 87 (CY 1987 GAA) or from any unappropriated funds of the National Treasury. For succeeding years, the wage increase shall be paid from the respective lump-sum appropriations for salaries/wages reflected in the agency budgets.

5. RESPONSIBILITY OF THE HEAD OF AGENCY

The head of the agency or entity shall be held responsible and personally liable for any payment of wage increase not in accordance with the provisions of this Circular.

6. REPORTING REQUIREMENTS

The head of department, bureau and/or agency shall submit to the CPOB a list indicating the position, the number and amount of wage increase involved every quarter thereof after the implementation of this Circular.

7. EFFECTIVITY

The wage increase provided herein shall take effect December 14, 1987.

8. SAVING CLAUSE

Cases not covered by the provisions of this Circular shall be referred to the Department of Budget and Management for resolution.
