CREATING AND ESTABLISHING THE TECHNICAL PANELS FOR ARTS AND SCIENCES, TEACHER, MEDICAL, BUSINESS AND NAMES THE RELATED EDUCATION PROGRAMS

- t. Section 50 of Batas Pambanae Bilang 252, otherwise known as the Education Act of 1982, provides that the "Board of Higher Education may create technical banel of experts in the various disciplines which shall serve as advisory and consultative bodies to the Board, as the need arises."
- The Technical Panel Concept. The Technical Panel approach as a rationalization mechanism has been regarded as one of the datalysts in upgrading the quality of the higher education system in the Philippines. In esquace, the Technical Panels are ad how bodies of experts in the various fields of specialization or disciplines which are intended to provide the necessary expertise that are normally not available in the bureaucracy. The Panels serve in a consultative, advisory and recommendatory capacity to the DEGS through the Board of Higher Education and the Bureau of Higher Education on matters relating to their specific discipline, field or area of concentration. The Panels are perceived as competent multi-sectoral and collegial bodies tasked to study and recommend strategies to rationalize and make more effective the higher education system in several as regards their programs, facilities, personnel, organization, operation, funding and output standards.
- 3. Creation of Wechnical Panels. Pursuant to this provision and in pursuit of rationalizing and giving direction to the various aducational and professional programs, the creation and establishment of the Technical Panels for Arts, and Sciences, Business, Health Related, Legal and Criminology, Medical, Maritime and Teacher Education is hereby ordered.

Composition of the Technical Panels

a. The Technical Panels shall be composed of sectoral representatives, outstanding schoolfors, practitioners and experts who shall be appointed or designated by the Secretary of the Department of Education, Culture and Sports.

- b. The Director of the Bureau of Higher Education as representative of the Secretary shall serve as Chairman of the Technical Panels.
- c. The members of the Technical Panels shall be a representative of the following:

5. Functions

In general, the Technical Panels shall assist the DECS through the Board of Higher Education and the Bureau of Higher Education in the formulation of relevant policies, provision of technical assistance, and promotion and enhancement of the productivity of the system of higher education in the country. They shall provide direction and assistance in the planning, development and implementation of institutional program in their respective disciplines.

- 6. In addition to the Technical Panel members, the Chairman may retain the services of experts/consultants either on a full-time or part-time status as technical committee members, resource persons or evaluators in pursuit of the objectives of the panels.
- 7. The Technical Panel members, as well as the experts/consult-ants will receive monthly honoraria/allowances as authorized under existing accounting and auditing rules and regulations.
- 8. Implementing guidelines for the operation of the Technical Panels shall be issued in a separate Order.
