RESOLUTION NO. 2365

The Commission on Elections, pursuant to the powers vested in it by the Constitution, the Omnibus Election Code, Republic Act No. 6666 and 7166 and other election laws, has  
**RESOLVED** to deploy Reserved Officers Training Corp (ROTC) Cadets, both male and female, for poll duties in connection with the May 11, 1985 elections, and to deputize, as it hereby depetrizes, the Commanding General of the Metropolitan Reserve Officers Training Corp Command and the Comandants of the Regional Civil Defense Unit of the Armed Forces of the Philippines and as such deputies, they are hereby placed under the control and supervision of the Commission on Elections and directed:

1. To furnish immediately the Commission on Elections, through the Deputy Executive Director for Operations, with a list of all cadets under their supervision, both male and female stating their respective ages, residences and schools where they are enrolled;

2. That each said ROTC cadet under their supervision shall be informed that the Commission has deputized and will deploy them for

poll duties as commission watchers in connection with the aforesaid elections, subject to the following conditions:

- a) The ROTC cadet shall be at least 18 years old as of the day of the election;
  - b) shall voluntarily offer himself for the purpose;
  - c) shall agree to be assigned anywhere within the province or city;
  - d) shall submit to normal disciplinary measures imposed upon ROTC cadets;
  - e) while on duty as commission watcher, shall wear his/her complete uniform as ROTC cadet, as well as an arm band, white cloth with the inscription: "ROTC COMELEC DEPUTY" and carry an ID card to be issued by the Commission;
  - f) shall perform such duties as the Commission or its duly authorized representatives in the field may impose upon him/her from time to time in the interest of free, orderly, honest, peaceful and credible elections; and
  - g) shall cooperate with other Commission deputies or representatives in the field and with the Board of Election Inspectors in the polling place or polling places to which he/she is assigned.
3. To submit immediately to the Commission, not later than March 20, 1992, a list of ROTC cadets who have volunteered.
4. To comply with the directives which the Commission on Elections may issue from time to time.

The ROTC cadets shall be deployed on election day in such urban areas or "poblaciones" of municipalities only as

may be determined by the Chairman of the Commission upon recommendation of the Commissioner-in-charge of the Region. For a more effective coordination and implementation of the directives of the Commission relating to the deployment and participation of ROTC cadets, the Commanding General of the Metropolitan Reserve Officers Training Corp Command (MROTC) is hereby designated as COORDINATOR AND OFFICER-IN-CHARGE for Metropolitan Manila, the Area Commanders for their respective areas and a senior ranking Officer in the General headquarters to be designated by the Chief of Staff of the AFP as the OVER-ALL COORDINATOR nationwide, of all ROTC units and cadets who are hereby deputized by the Commission in connection with the May 11, 1992 elections.

For each day of actual duty, each ROTC cadet actually deployed by the Commission shall be entitled to an allowance of one hundred pesos (P100.00) per day of service, which aggregate fund requirement shall be shared by the Commission on Elections and the Department of National Defense on the basis of their respective commitments and such other provisos that they may later agree upon, plus individual death, disability, accident and hospitalization insurance in an amount not exceeding (P50,000.00), the premiums of which shall be borne by the Commission.

The Executive Director and the Deputy Executive Director for Operations shall implement this resolution.


This resolution shall take effect on the seventh day after its publication in two (2) daily newspapers of general circulation in the Philippines.


The Education and Information Department is hereby directed to cause the publication of this resolution in two (2) newspapers of general circulation in the Philippines, and furnish copies to the Secretary of National Defense.




