AMENDMENTS TO THE GUIDELINES FOR THE IMPLEMENTATION
OF THE COLLEGE FACULTY DEVELOPMENT FUND PROGRAM
FOR SY 1992-1993

To: Bureau Directors
Regional Directors
Heads of Private Schools, Colleges, and Universities

1. DECS Order No. 60, s. 1991 is hereby amended as follows:

- a. Financial Assistance for the Master's/Doctoral Program shall include tuition and other school fees to be billed by the school but not to exceed ₱4,500.00 per semester.
- b. For the dissertation/thesis writing grant, tuition and other school fees including expenses for the oral defense shall, likewise, be billed by the school but not to exceed the amount of ₱10,000.00 per semester.

2. The same priority courses stated in DECS Order No. 60, s. 1991 shall be observed in addition to Teacher Education, major in the Sciences and Mathematics.

3. The GASTPE Unit of the Higher Education Division in each region shall allocate and distribute the CFDF slots based on the needs of the region and on the number of private higher education institutions offering the priority courses in that region.

4. All other provisions of DECS Order No. 60, s. 1991 shall remain enforced unless otherwise amended.

5. Immediate and wide dissemination of this DECS Order is enjoined.

Rule V

FINANCIAL ASSISTANCE

Section 1. An amount of ₱8,950.00 per semester and ₱6,850.00 per summer including ₱1,000.00 for transportation expenses, or ₱24,750.00 per school year shall be allocated for a beneficiary pursuing the masteral or doctoral programs on full-time scholarships carrying a load of 12 academic units per semester and 9 units in summer.

Section 2. For part-time beneficiaries in the master's/doctoral degree programs, the amount of entitlement shall be determined by the academic load that the scholar will carry per semester/summer. The amount shall not exceed ₱15,850.00 per year.
