MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT made and entered into by and between:

The DEPARTMENT OF EDUCATION, CULTURE AND SPORTS (DECS) with office address at the University of Life Complex, Meralco Avenue, Pasig, Metro Manila; herein represented by its Secretary, Isidro D. Carino, hereinafter referred to as DECS.

The DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), with office address at Sanfascio Drive, Port Area, Manila; herein represented by its Secretary, Jose P. de Jesus; hereinafter referred to as DPWH.

WITNESSETH:

WHEREAS, the 1992 General Appropriations Act provides that the DECS Schoolbuilding Program shall be administered and implemented by DPWH.

WHEREAS, it is believed that DECS, in view of its experience in implementing the 1991 Schoolbuilding Program, can assist in the implementation of the 1992 Schoolbuilding Program.

WHEREAS, the schoolbuilding projects funded under the 1992 General Appropriations Act have to be completed in time for the opening of classes in June 1992.

WHEREAS, DECS and DPWH have agreed to collaborate in project implementation to facilitate the execution and completion of projects.

NOW, THEREFORE, for and in consideration of the foregoing premises and mutual covenants and agreements hereinafter set forth, the parties have agreed as follows:

ARTICLE I COVERAGE OF THE AGREEMENT

This AGREEMENT shall cover the implementation of projects in all regions of the country except such projects which may be assigned to DECS for full implementation with the agreement of DPWH pursuant to Articles II and III.

ARTICLE II
RESPONSIBILITIES OF DECS

Prepare the lists of schoolbuilding projects to be implemented under the 1992 Schoolbuilding Program and furnish a copy of such lists to DPWH.

Submit a request to the Department of Budget and Management for the release of funds for the 1992 Schoolbuilding Program.

Evaluate and approve requests for realignment of schoolbuilding projects submitted by Congressmen and other concerned parties and inform DPWH of approved realignment of projects.

Designate a representative from the DECS Division Office who shall be an observer in the opening of bids by the DPWH Prequalification, Bids and Awards Committee.

Provide DPWH of the approved standard schoolbuilding designs to be used for the projects under the Schoolbuilding Program.

Assist in monitoring project implementation in accordance with the approved program of work.

Inspect the completed projects and accept the same.

Inform DPWH of the proposed uses of any savings realized.

Implement such schoolbuilding projects as may be agreed upon with DPWH.

ARTICLE III
RESPONSIBILITIES OF DPWH

On the basis of project listings submitted by DECS, prepare a program of work for each project using the standard schoolbuilding designs approved by DECS and furnish DECS a copy of the program of work for each project.

Implement the projects through appropriate procurement schemes in accordance with pertinent government rules and regulations.

For projects to be implemented through public bidding, undertake the bidding and awarding of projects and other pre-implementation activities related thereto.

Allow the DECS representative to be an observer in the opening of bids and inform DECS of the winning contractor for each project and the amount of the winning bid.

5. Inform the winning contractor that the project will be jointly monitored by DECS and DPWH.
6. Inspect the projects on a periodic basis in coordination with the DECS representative in the project site.
7. Process progress billings in relation to the work accomplished and inform DECS of progress payments and status of physical completion.
8. Furnish DECS with monthly status reports for each school division.
9. Sub-allot/Transfer to DECS the funds for such schoolbuilding projects to be implemented by DECS as may be agreed upon.

ARTICLE IV
EFFECTIVITY

This AGREEMENT shall take effect immediately upon signing hereof and may be amended or modified upon mutual agreement by both parties and shall automatically terminate upon the satisfactory fulfillment of all terms and conditions embodied herein.

IN WITNESS, WHEREOF, the Parties have signed this AGREEMENT this 11th day of March, 1992 at Metro Manila, Philippines.
