DESIGNATING THE MEMBERS OF THE TECHNICAL PANELS  
FOR THE VARIOUS HIGHER EDUCATION PROGRAMS

7. The Director of the Bureau of Higher Education shall serve as co-chairman of all technical panels.

8. All chairmen and members of the technical panels and technical committees, in consideration of their services, shall receive honoraria/allowances as authorized under existing rules and regulations.
