1. R.D. No. 1992-1993 provides for the provision of contracts to students and teachers in public education and postsecondary education. These contracts are for the provision of goods and services which are implemented at the secondary level. Educational Service Contracting (ESC) and Tuition Fee Supplement (TFS).

2. The provisions of the 1992-1993 Order No. 57, of 1992 which provide for the provision of goods and services to students and teachers in public education and postsecondary education are contained in paragraphs 2 and 3 of the Order. The provisions of the Order are to be implemented by the State Directors and District Office Directors.

3. Effective 10/1/92, the payment for the provision of goods and services to students and teachers in public education and postsecondary education shall be made by the State Directors and District Office Directors to the ESC and TFS providers.
