SUBJECT: Designating DTI Regional/Provincial Directors as NCAC Coordinators

- 1. In the interest of the service and in view of the full implementation of Republic Act 7394, the Consumer Act of the Philippines, all Regional and Provincial Directors of the Department of Trade and Industry are hereby designated Coordinators of the National Consumer Affairs Council (NCAC) in their respective areas, in addition to their regular functions.
- As NCAC Coordinators, they shall coordinate with the appropriate regional government offices in the area which are performing functions under the Act. They shall conductive regular dialogue with these agencies and explore the areas in which DTI and shaid agencies can further cooperate for consumer protection.
