**SUBJECT :** Further Clarifying Certain Provisions OF DECS, DBM and DILG Joint Circular Nos. 01 s. 1998 and 01-A s. 2000 dated 14 April 1998 and 14 March 2000, Respectively

**1.0 PURPOSE**

This Joint Circular is being issued to further clarify the utilization of the Special Education Fund (SEF).

**2.0 PRIORITIZATION OF EXPENSES CHARGEABLE TO SEF**

2.1 Section 2.0 of Department of Education, Culture and Sports-Department of Budget and Management-Department of the Interior and Local Government (DECS-DBM-DILG) Joint Circular No. 01-A dated March 14, 2000 is hereby clarified to include among the priority items chargeable to SEF, the payment of salaries and authorized allowances of teachers hired to handle new classes as extensions of existing public elementary or secondary schools established pursuant to Section 2.1 of the said Joint Circular.
