CONTRACTING AND THE EDUCATION VOUCHER SYSTEM
FOR SCHOOL YEAR 2008-2009

1. As part of the Government's continuing commitment to expand access to public secondary education and assist students in private education, this Department is pleased to announce the provision of additional student grants for the Education Service Contracting (ESC) and Education Voucher System (EVS) for SY 2008-2009.
2. The guidelines for the availment of the grants for the Education Service Contracting (ESC) and Education Voucher System (EVS) are provided in Enclosure No. 1.
3. The Regional and Division Offices are advised to facilitate the distribution of student grants to the graduating grade six pupils from public elementary schools in districts where public secondary schools have acute classroom shortages as indicated in Enclosure No. 4.
4. Immediate dissemination of and compliance with this Order is directed.

School Year 2008-2009

I. Introduction

A. Legal Basis

Article XIV of the 1987 Constitution of the Republic of the Philippines provides the legal basis for the Education Service Contracting (ESC) and the Education Voucher System (EVS) as articulated in the following provisions:

The State shall protect and promote the rights of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all. (Sec. 1)

It is the policy of the State to establish and maintain a system of scholarship grants, student loan programs, subsidies, and other incentives which shall be available to deserving students in both public and private schools, especially to the underprivileged (Sec. 2-3)

The State recognizes the complementary roles of public and private institutions in the education system. (Sec. 4-1)

B. Education Service Contracting (ESC)

Republic Act 8545 (amending R.A. 6728), otherwise known as the "Expanded Government Assistance to Students and Teachers in Private Education (GASTPE)," stipulates that it is the declared policy of the State, in conformity with the mandate of the Constitution, to promote and make quality education available to all Filipino citizens. Through this law, the State also recognizes the complementary roles of public and private schools in the education system; especially the latter's invaluable contribution to education. For 24 years, after the pilot test of the program in 1982-1984, Education Service Contracting has become a symbol of private-public school partnership in making quality secondary education accessible to all Filipino children.

C. Education Voucher System (EVS)

The program was launched in March 2006 as a pump-priming program of the Office of the President and is geared towards reducing the class size to more

manageable levels in public high schools especially those experiencing shortage of classrooms and teachers.

D. Goals of the ESC and EVS Programs

Both programs are systems of financial assistance aimed at democratizing and improving access to quality basic education at the secondary level through government extension of financial assistance to poor but deserving elementary school graduates who wish to pursue their secondary education in private schools of their choice.

Program beneficiaries are awarded one-time certificates (ESC) and vouchers (EVS) as evidence of Government's commitment to support their education in a private high school they choose for as long as they meet the entrance requirements as well as those for regular promotion to each of the succeeding school years until they graduate.

II. General Guidelines for SY 2008-2009

The following general guidelines shall apply to both the ESC and EVS programs.

A. Amount and Terms of the Subsidy

1. The subsidy for all grantees from 1st to 4th Year levels, except first year slots in the NCR, shall be at P5,000 per grantee per school year.
2. The grant amount for first year slots in the NCR where the average tuition fee is higher than the national average and where there is acute classroom shortage shall be P10,000 per grantee.

For participating schools in the NCR, acceptance of grantees shall be limited to those that completed their elementary education in schools located in the NCR only.

3. The award of a subsidy starts at the first year level.
4. The subsidy once awarded a grantee covers his/her entire four (4) years of high school in an ESC or EVS participating private high school provided that the grantee is promoted to the subsequent year levels until he/she graduates.
5. The subsidy to the grantee ceases when he/she drops, fails a year level, or transfers to a non-participating private school or public school, except in cases due to sickness and he/she is able to provide a medical certificate.
6. The subsidy is only a partial subsidy when a school's tuition and other fees (standard and non-standard fees) exceed P5,000 unless the school opts to

condone a portion or all of the difference otherwise, the differential is borne by the grantee.

B. School Participation

1. Only government-recognized private secondary schools may participate in the programs provided they have passed the Certification Program and have a **dropout reduction program** in place. The Certification Program determines if a school meets the DepED minimum requirements for secondary educational institutions.
2. Night schools or branches of schools wishing to participate as service providers must have separate government recognition and passed ESC Certification before they are considered for participation in the programs.
3. Government recognized private secondary schools that wish to undergo Certification as a requisite for participation in the programs may write a letter of intent with their contact details to their respective DepED Division Superintendents who shall in turn endorse their letter to the concerned FAPE Regional Program Coordinators (RPCs) whose names, contact numbers and addresses are provided with these guidelines.
4. Participating schools with unresolved ownership disputes shall be disqualified from the programs.
5. All participating schools must make themselves available for monitoring and evaluation by a joint DepED and FAPE monitoring team as well as participate in research studies aimed at improving the programs' effectiveness.

III. Specific Program Guidelines

ESC Program

A. Slot Allocation

1. 1st Year slot allocation for each participating school shall be equal to the number of 1st Year grantees in SY 2007-2008 but not less than 50 slots.
2. Fifty (50) freshman slots shall be allocated to new participating schools.
3. Additional slots, if any, shall be available to schools that received ratings of Above Standard or Within Standard in the Certification Program. Priority shall be given to schools with low or no dropouts and those that are willing to condone a portion or the total difference between the grant amount and their tuition and other fees (TFOFs).

4. Participating schools rated Disqualified in the Certification Program shall not be awarded any slots for the first year level. However, their remaining grantees shall continue to receive the subsidy until they graduate.

B. Grantee Selection

1. The selection of first year grantees by participating private schools shall be done in such a way that at least 80% come from public elementary schools and 20% from private elementary schools, except in areas where there are no feeder public elementary schools.
2. The Regional Program Committees (RPCom) shall meet to determine the distribution of their region's allocation of additional slots (see **Enclosure 2**).
3. A School Committee in the private high school convened by the principal as chairman with a parents' association representative and a faculty association representative as members shall be responsible for the screening and selection of grantees to fill the program slots allotted the school. The Committee shall also be responsible for orienting the grantee and his/her parents/guardian on the program and its guidelines.
4. The criteria for selection are as follows:
 - a. The applicant meets the admission requirements of the school
 - b. Priority shall be given to applicants from families whose basic incomes are within or below the poverty thresholds determined by NEDA for 2006-2007 as follows:

P14,103 per month in rural areas
P16,936 per month in urban areas, except Metro Manila
P19,345 per month in Metro Manila
 - c. The applicant receives a favorable assessment by the School Committee with regard to his/her parent's/guardian's commitment to support the applicant's completion of secondary education under the program.
5. Once an applicant is accepted as a grantee, the private school inputs the grantee's name and other information in the ESC program forms (see Documentation). (All program forms are accomplished on a yearly basis and submitted to the respective FAPE RPCs).
6. The deadline for schools' submission of program forms to the FAPE RPCs is on or before August 15, 2008. The deadline for FAPE RPCs' submission of school documents to FAPE in Manila is on or before September 15, 2008.

EVS Program

A. Slot Allocation

1. The DepED Central Office shall prepare the voucher allocation per region (see **Enclosure 2**) on a pro rata basis in accordance with its priority areas, i.e. those with low participation rates and high classroom shortages.
2. The RPCom shall meet soon after the issuance of the guidelines to determine distribution of slots allocated their respective regions (see **Enclosure 2**) to public elementary schools that are feeder schools of public high schools in the priority areas where there are both EVS and ESC participating schools.
3. The appropriate number of EVS vouchers shall then be provided to the concerned DepED Division Superintendents for distribution to public elementary schools.

B. Grantee Selection

1. Grantees of the EVS program must come exclusively from public elementary schools as well as PEPT and ALS first year qualifiers that wish to avail of the subsidy.
2. The principals of concerned public elementary schools identified by the DepED Division Offices shall be responsible for the selection and orientation of grantees or recipients of vouchers allocated to their schools. The principals shall inform the grantees that they must get themselves enrolled in the participating private high school by June 30, 2008. Furthermore, they shall provide the EVS grantee with a list of participating EVS and ESC schools where their vouchers can be used.
3. Grantees selected by public elementary school principals shall each be provided with an EVS Voucher and a Certification Letter (copy enclosed) as well as a copy of this program information, guidelines, and procedures that the grantee shall present along with other admission requirements to the principal/registrar of the participating private school.
4. A School Committee in the private high school composed of the principal as chairman, parents' association representative and faculty association representative as members shall decide whether or not to accept the EVS grantee based on the same criteria used in the ESC program (III B 4) and shall orient the parents/guardians of the grantee on the program and its guidelines.
5. If the School Committee accepts the EVS grantee, it accomplishes the detachable portion of the Certification Letter submitted by the grantee and ensures its delivery to the concerned public elementary school principal not

later than July 15, 2008. The Committee has the parent/guardian sign at the back of the EVS Voucher awarded the grantee. The EVS Voucher is kept by the school and made available for inspection by the DepED-FAPE monitoring team.

6. If the EVS grantee is not accepted by the School Committee, the grantee retrieves all documents presented to the school and tries other participating private schools.
7. Upon receipt of the detached portion of the Certification Letter, the public elementary school principal prepares a summary of the names of EVS grantees that were accepted by private high schools and submits this to the concerned DepED Division Superintendent not later than July 30, 2008.
8. The Division Superintendents shall prepare a summary of the EVS grantees submitted by the public school principals and submit this to the RPCom that shall prepare a summary report of the list of grantees submitted by the Division Superintendents and submit this to the BSE in DepED Central.
9. The participating private schools that accept EVS grantees accomplish the appropriate EVS program forms (see Documentation). (All EVS program forms are accomplished on a yearly basis to track the grantees and are submitted to the respective FAPE RPCs).
10. The deadline for schools' submission of fully accomplished EVS program forms and required documents to the FAPE RPC is not later than August 15, 2008. The deadline for FAPE RPCs' submission of school documents to FAPE in Manila is on or before September 15, 2008.

IV. Documentation and Processing of School Documents

A. Program Forms

1. All pertinent program forms including the DepED's Basic Education Information Statistics (BEIS) that must be accomplished for both programs are available for downloading at www.fape.org.ph.
2. An orientation shall be conducted in every region to explain, among others, how to accomplish these forms. Among these forms is the Billing Statement which when submitted along with the other program forms to the FAPE RPCs, is the basis for payment of the grants to the schools.
3. All participating schools must keep a complete set of these documents along with the necessary attachments on file, for review by the joint DepED-FAPE monitoring team.

B. Processing of Claims

1. Processing of school documents both at the RPC and at FAPE National Office shall be done on a first-come, first-served basis.
2. The documents shall be checked for accuracy and completeness by the RPC before these are sent to FAPE in Manila for final checking and consolidation of individual school billing statements in batches for submission to the Bureau of Secondary Education (BSE) in DepED Central Office. The batch numbers indicate the priority or queuing order of payment of schools.
3. The BSE reviews the submitted consolidated billing statements and accompanying documents and signs these before turning them over to DepED Accounting Division for processing of payment.
4. The BSE informs FAPE of number of batches of billing statements turned over to DepED Accounting Division and the schedule of payment. Participating schools may inquire on the status of their submitted documents with the respective FAPE RPCs (see **Enclosure 3**). For batch numbers, they may call FAPE in Manila thru tel. Nos. (02) 892-1466 or 894-2475.

V. Payment of Grants and Management Fees

DepED Central's Accounting Division shall make payment of grants to participating schools' only through school bank accounts with the Land Bank of the Philippines (LBP). The bank account names participating schools must be in the name of the school only.

Management fees due FAPE at P100 per grantee are to be paid by DepED Accounting Division based on the number of grantees per batch of consolidated billing statements received from the BSE.

The projected payout schedule for the programs budget shall be as follows:

1. Twenty-five per cent (25%) within September 2008;
2. Fifty per cent (50%) within October 2008 and;
3. Twenty-five per cent (25%) within November 2008

VI. Grounds for Suspension/Termination of School Participation

1. Falsification of data or information in any of the program forms and related attachments.

2. Padding and/or inclusion of “ghost students” in the list of grantees. This refers to the following:
 - a. Grantees listed in the program forms that attend classes in another campus branch, or unit with an address that is different from the one indicated in the program forms of the school.
 - b. Students listed as enrolled but have not attended classes up to the first 2 months of classes.
3. Charging grantees in excess of a school’s actual tuition and other fees.
4. Undue delay or non-reimbursement of tuition and other fees advanced by grantees to support school operating requirements while grants have not yet been paid the school.
5. Double listing of a grantee/s in both ESC and EVS programs.

Schools violating any of these program guidelines shall be accorded due process before DepED imposes sanctions based on the recommendation of the RPCom and/or the joint DepED-FAPE Monitoring Team.

VII. Program Management

The DepED as implementing agency of the ESC and EVS programs has contracted the PEAC (FAPE) Secretariat to assist in the implementation of the program particularly in dealing with private high schools covered by the program.

Structure and Roles

A. PEAC (FAPE) National Secretariat

The National Secretariat shall perform the following functions:

1. Assist in the formulation of the Implementing Guidelines and Procedures for review, approval and endorsement by DepED.
2. Coordinate with DepED Central Office on program information dissemination and implementation through issuance of DepED Orders/Memos.
3. Designate Regional Program Directors (RPDs) and Coordinators (RPCs) for the Regional Program Secretariats (RPS). Monitor and evaluate their performance.
4. Provide the respective Program Forms to participating schools whose accomplished forms shall serve as basis for payment of grants to schools.

5. Receive, review/check, and process school Program Forms supporting documents forwarded by the Regional Program Secretariats.
6. Certify to the accuracy and completeness of school documents processed for submission to and payment by DepED Central Office.
7. Maintain a database on participating schools and grantees and generate reports on tuition fees, enrolment, dropouts, transferees, retention and promotion rates, etc.
8. Conduct Certification Program visits on participating schools to help ensure they meet DepED minimum standards for high schools.
9. Conduct In-Service Trainings for participating schools' administrators and teachers and conduct Research on how to improve the programs.
10. Submit program status/terminal reports to DepED including recommendations for the improvement of program implementation.

B. Regional Program Secretariat (RPS)

1. The RPS is composed of the following:
 - a. Regional Program Director (RPD) designated by the PEAC (FAPE) Secretariat shall exercise general supervision of the programs' implementation in the region.
 - b. Regional Program Coordinator (RPC) who manage the day-to-day implementation of the programs in accordance with Program Guidelines and coordinate its efforts with members of the Regional Program Committee (RPCom).
2. Other functions of the RPS:
 - a. Provide advisory, guidance and assistance to the participating schools in the proper accomplishment of Program Forms and supporting documents.
 - b. Receive and undertake first level review of the completeness and accuracy of the documents submitted by the participating schools.
 - c. Forward to the PEAC (FAPE) National Secretariat the Program Forms.
 - d. Monitor participating schools' compliance with Program Implementing Guidelines and Procedures and verify existence of

grantees through monitoring visits to schools through a joint monitoring team composed of the DepED Regional Supervisors in-charge of Private Schools or their representative and RPS representatives.

- e. Submit monitoring and implementation reports to the PEAC (FAPE) National Secretariat and the RPCom.

C. Regional Program Committee (RPCom)

1. The Regional Program Committee shall be composed of the following:

- a. DepEd Regional Director as Chair
- b. FAPE Regional Program Director as Co-chair
- c. DepEd Region Chief of Secondary Education as member
- d. DepED Region Chief of Elementary Education as member
- e. FAPE Regional Program Coordinator as member
- f. DepED Division Superintendents as members

2. The RPCom shall perform the following functions:

- a. The DepED Regional Director as Committee Chair shall be responsible for convening the Committee to a meeting as soon as these guidelines are issued to determine 1) EVS voucher allocation and distribution to public elementary schools and, 2) Distribution of additional ESC regional slot allocation to private schools. The exact number of slots for Items 1 and 2 are found in **Enclosure 2**.
- b. The DepED Regional Director as Committee Chair shall issue the necessary DepED Memo for the conduct of a one-day regional program orientation assembly in the region for participating schools and concerned DepED Division Offices as soon as DepED Central Office issues an Order/Memo on the Program Guidelines and Procedures.
- c. Oversee the implementation of the programs in the region in accordance with the Program Guidelines and Procedures, resolve problems that may occur and recommend measures to improve the implementation of the programs.
