NCDA BOARD RESOLUTION NO. 12 S/2008

RESOLUTION ENJOINING THE MEMBER AGENCIES OF THE NATIONAL COUNCIL ON DISABILITY AFFAIRS BOARD TO EMPLOY QUALIFIED PWD ENCODERS USING AVAILABLE RECRUITMENT SCHEMES

WHEREAS, as provided for in Article 27 of the Convention on the Rights of Persons with Disabilities, states parties recognize the right of persons with disabilities to work, on an equal basis with others; inclusive of the right to the opportunity to gain a living by work freely chosen or accepted in a labor market and work environment that is open, inclusive and accessible to persons with disabilities;

WHEREAS, states parties shall safeguard and promote the realization of the right to work, prohibit discrimination on the basis of disability with regard to all matters concerning all forms of employment, including conditions of recruitment, hiring and employment, continuance of employment, career advancement and safe and healthy working conditions;

WHEREAS, having ratified and in compliance with the Convention, the Philippine government shall promote employment opportunities and career advancement for persons with disabilities in the labor market, as well as assistance in finding, obtaining, maintaining and returning to employment; and employ persons with disabilities in the public sector;

WHEREAS, given the exemplary performance of the 19 PWD encoders piloted in the passport processing crew of the Department of Foreign Affairs, similar initiatives are requested from the participating members of the NCDA Governing Board, to upscale work opportunities for deserving persons with disabilities;

RESOLVED, AS IT IS HEREBY RESOLVED, upon the recommendations of the Sub-Committee on Information and Communication Technology and Executive Committee, the Board enjoins the member agencies of the NCDA Board to hire qualified persons with disabilities as encoders to perform other necessary functions in their offices using available recruitment schemes.
