CREATION OF ORGANIZATIONAL DEVELOPMENT (OD) AND LIVELIHOOD/TECHNICAL AND VOCATIONAL EDUCATION TECHNICAL WORKING GROUPS (TWGs) UNDER BESRA

- 1. To ensure the effective and efficient operationalization of the structures and mechanisms adopted for the implementation of Basic Education Sector Reform Agenda (BESRA), there is a need to create additional Technical Working Groups (TWGs), namely: Organizational Development TWG and Livelihood/Technical and Vocational Education TWG.
- 2. The abovementioned TWGs will be the main forum for all overall coordination and monitoring of the implementation of their respectively assigned areas of BESRA and for developing recommendations in terms of standards, policies and operational guidelines related to BESRA implementation.

- 7. All concerned offices/organizations are requested to submit name(s) of their official representatives and/or permanent alternates to the assigned TWGs to the BESRA Secretariat.
- 8. Immediate dissemination of and compliance with this Order is directed.
