- d. Prepare and submit the necessary report/s on the Committee's findings and recommendations to the undersigned, as well as the action documents addressed to the concerned PLIs.
- 4. The Chairman shall report from time to time, the updates of the validation being made by the Committee.
- 5. Transportation and other incidental expenses relative to the said activities, as well as the honorarium, as may be allowed, shall be charged to OSEC Funds, subject to the usual accounting and auditing rules and regulations.
