
#### DANGEROUS AND CONTROLLED DRUGS

The use of some drugs like shabu, ecstasy, and other dangerous drugs is illegal under any circumstances. These substances are highly potential for abuse and have no medical use. Some drugs have dual status: their use can either be legal or illegal. Amphetamine use for example is legal when bought with the prescription of a doctor. It becomes illegal when obtained from illegal sources and through illegal means.


Doctors prescribe amphetamines to individuals with health problems, to help them suppress their appetite thus lose weight. Other people take this to fight depression and fatigue without the doctor's advice. The serious side effects and widespread use of this drug resulted to the passing of controlled substances act in some countries.

Examples of prohibited drugs are shabu, opium, heroin, ecstasy, marijuana. These drugs have no medical use. These are illegal drugs. To sell, buy, use, possess these drugs is illegal.

Regulated/ controlled drugs have accepted medical use. These drugs have a high potential for abuse so the use is regulated or controlled. Amphetamine is one example of these drugs.

#### **PROVISIONS OF THE LAW REGARDING DRUG ABUSE**

THE Comprehensive Dangerous Drugs Act of 2002 took effect on July 4, 2002. This is an act repealing or revising Republic Act No. 6425, otherwise known as the Dangerous Drugs Act of 1972. In the new Comprehensive Dangerous Drugs Act of 2002 penalties for violations of the law are heavier than before. The following penalties for unlawful act are listed below.





What does DDB stand for? It is Dangerous Drugs Board. It's duties are to:

- → regulate the importation, distribution, manufacture, production, prescription, and dispensing of dangerous drugs necessary to meet the research and medical needs of the country;
- → coordinate with law enforcement agencies to effect the apprehension of drug offenders and the confiscation of dangerous drugs;
- → take charge and custody of all seized, confiscated, surrendered dangerous drugs;
- → encourage, assist, and accredit private rehabilitation centers;
- → develop information and education program; and
- $\rightarrow$  conduct researches related to dangerous drugs.

The **Philippine Drug Enforcement Agency** (PDEA) is the implementing arm of DDB. It is responsible for the efficient and effective law enforcement of all the provisions on any dangerous drug and/or controlled precursors and essential chemicals.

**Philippine Mental Health Association** (PMHA), (DARE), (PREDA), and (MALAYA) center provide services to help rehabilitate drug dependents. The **Department of Health** (DOH) oversees and monitors all drug rehabilitation and intervention programs. The **Department of Social Welfare** (DSWD) is in charge of the guidelines for the treatment and rehabilitation of drug dependents.

#### Avoid Drug Abuse, Make Healthy Decisions

You make decisions on all the things you do. You make choices. Your choices and decisions affect your safety. They also affect your feelings and actions. Making wise decision is one of the most important skills everybody must learn and practice.

Making responsible decision is helpful to avoid drug abuse. How do you know if your decision is a responsible one? Let's see these criteria.


A decision is responsible if your action will:

- help maintain/ promote health
- ➢ be safe
- $\blacktriangleright$  not violate the law
- ➤ show respect to oneself and others
- follow parents' instructions
- show good behavior

Young people like you need the opportunity to develop skills in making responsible decisions about your health. Think carefully before making any delicate decision. On the use of dangerous drugs, it is important to bear in mind that NOT EVERYONE IS DOING IT.

In turning down an invitation to try drugs, you must:

- → Clearly say "NO" and avoid half-heated responses like "well, I don't think so." Do not argue, don't discuss, just say "NO" and show that you mean it.
- ➔ Give reasons for saying "NO." "My coach says drugs will hurt my game," "drugs is against my religion," are examples of excuses.
- $\rightarrow$  Tell the other person what can be done instead.
- → Be firm but not offending. Use humor.


