President Arroyo maintained yesterday that she has never and will never use her position for personal profit even as she strongly denied manipulating her statements of assets, liabilities and net worth (SALN) that showed her net worth doubling in the last eight years.

Her lawyer, Romulo Macalintal, said the President vehemently denied "any report or speculation alleging defect or her non-compliance with the law in filing her SALN."
